Rapid tournament Rules and Regulations:

- 1.SYSTEM OF PLAY : THE TOURNAMENT WILL BE PLAYED UNDER FIDE'S LAWS OF CHESS AND THE SWISS SYSTEM. A TOTAL OF 9 ROUNDS SHALL BE PLAYED.
- 2.TIME CONTROL : THE RATE OF PLAY SHALL BE 10 MINUTES WITH AN INCREMENT OF 5 SECONDS PER MOVE FROM MOVE NUMBER ONE
- 3.PROTEST, IF ANY, SHALL BE MADE IN WRITING WITH A PROTEST FEE OF RS. 1000/- WITHIN 15 MINUTES OF THE OCCURRENCE OF THE INCIDENT. THE PROTEST FEE WILL BE REFUNDED IF THE APPEAL IS UP HELD.
- 4.REGISTRATION TO THIS EVENT IS AN AUTOMATIC CONSENT GIVEN BY THE PLAYER FOR RECORDING OR CAPTURING HIS/HER GAMES OR PICTURES DURING THE ROUND.
- 5.APPEALS COMMITTEE : BEFORE THE COMMENCEMENT OF THE TOURNAMENT, A FIVE MEMBER APPEALS COMMITTEE SHALL BE FORMED.
- 6.ELECTRONIC DEVICES: ALL ELECTRONIC ITEMS INCLUDING WRIST WATCHES (ALL TYPE OF WATCHES) ARE NOT ALLOWED IN THE TOURNAMENT HALL.
- 7.LATEST TIE BREAK RULES WILL BE USED.
- 8.PRIZES WILL NOT BE SHARED, ONE PLAYER IS ELIGIBLE FOR ONE HIGHER PRIZE ONLY.
- 9.NO REFUNDS OF ENTRIES WILL BE PROCESSED ONCE ENTRY IS MADE.
