<b><i>AICF REGISTRATION</i></b>	ALL INDIAN PLAYERS MUST BE REGISTERED WITH AICF FOR THE YEAR 2023 -2024 BEFORE THE REGISTRATION DEADLINE TO PARTICIPATE IN THE TOURNAMENT.
